Definition:	Simple. Flexible. Donor (individual or business) makes gift to AACF, receives immediate tax deduction, and can advise the Foundation on grant recipients. Contribute to and make grants from the fund, as frequently as you like. Excellent alternative to private foundation.	General pool (may contain funds named by donor) administered by AACF and provided through gifts or bequests from many people. Funds used for grantmaking to local agencies and AACF initiatives.	A Fund established by an agency for the benefit of that agency. Fund may be permanently endowed or quasi-endowed (non- permanent).	A permanent or non- permanent fund established by an individual or organization for the benefit of one or more agencies.	A permanent fund used for a specific cause such as arts, education, or health and human services, but Community Foundation makes decision on recipient(s).	The Founders Society Fund is permanently endowed to support the annual operations of the Foundation.
